Minutes of the meeting held under the chairmanship of Shri. Iftikhar Husain Chauhan (president JAKFAS) on 20th of may 2022.

The Jammu based officer attended the meeting from the office of Shri. Iftikhar Hussain Chauhan(President JAKFAS) and Kashmir based officer attended the meeting from the office of Shri. Tasawaf Amin (Publicity Secretary) office.

The following agenda points were discussed in the meeting.

1. Nomination of Secretary General body

On the retirement of Shri. Azad Ahmed Wani, the committee unanimously nominated Shri. Imtiaz Ahmed Wani (Director Finance) present Director Budget Finance Department) as the new Secretary General body. In this regard executive body authorized the General Secretary to issue formal order on behalf of the society .The members further appreciated the work done by outgoing Secretary General for the welfare of Cadre and thanked him on behalf of Cadre.

2. Assured career progression

The members of executive body discussed the importance of ACP threadbare and it was decided that the case shall be followed vigorously at each step with competent authority so that accounts cadre should also get the benefit of ACP. At present this cadre is facing huge problem of stagnation which result in demoralization of officer as the two other services are already getting the benefit of ACP. Anand Thakur(Finance Secretary) further informed the members that the JAKFAS office already established at Jammu needs improvement in infrastructure including some furniture items, installation of an AC, Vis a Vis internet connection etc.

Since earlier there was no office accommodation at JAKFAS at Srinagar. The President JAKFAS has discussed telephonically with

Director Accounts and Treasuries Kashmir to provide us a suitable room for establishment of JAKFAS office in the premises of Office of Director Accounts and Treasuries Kashmir.

The Director Accounts and Treasuries Kashmir has agreed in principal to provide a room for establishment of JAKFAS office Srinagar

It was also decided that the said accommodation has been fully furnished for making the office fully functional.

4. Renewal of registration of society.

It was decided in the meeting that renewal of registration of society shall be taken up with Director Industries Kashmir by Vice President Kashmir Shri. Yasir Arafat in a time bound manner.

5. More visibility on Social Media

It was further decided in the meeting that both the social media in-charge Jammu and Srinagar in collaboration with Publicity Secretary will chalk out the strategy for publication of achievements/ work done by JAKFAS for the welfare of Accounts Cadre and general public.

6. Registration / Membership for Gazatted Officer

It was decided in the meeting that membership for new member's to be kept open for a period of (02) months. In this regard General Secretary has been authorized to issue a formal notice which shall be shared on all social media platforms for awareness/information of new members.


7. Seminar on Drug Abuse
